

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification Three to the Economic Development Department Initiative Budget)

RESOLUTION NO. 2000-310

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation approved the FY 2000 budget**
2 **for the Economic Development Department and other programs funded by the**
3 **Initiative Administrative Cost Appropriation by means of Resolution No. 99-539; and**
4 **WHEREAS, in Legislative Council approved certain educational and support activities for**
5 **individual clients and Districts in the FY 2000 budget for the Economic Development**
6 **Department; and**
7 **WHEREAS, the Economic Development Department has been unable to hire staff, or to conduct**
8 **these activities at the levels approved in the FY 2000 budget because of a lack of office**
9 **and classroom space; and**
10 **WHEREAS, the Economic Development Department has prepared a budget modification to**
11 **purchase a modular building, which will allow the Department to both increase staff**
12 **and offer educational support, within its existing FY 2000 appropriation.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
14 **takes the following actions:**

- 15 1. **Modification three of the FY 2000 budget for the Economic Development**
16 **Department (attached) is approved.**
17 2. **The Chairman of the Tohono O'odham Nation is authorized to negotiate and**
18 **execute all agreements that are needed to implement this budget.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
20 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
