RESOLUTION NO. 2000-311

1 **WHEREAS, the Tohono O'odham Nation is currently funding the Tohono O'odham Career Center**
2 **with Tribal and BIA 638 funds; and**
3 **WHEREAS, a Tribal Supplement budget is in place; and**
4 **WHEREAS, a modification has been submitted for review and approval.**
5 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
6 **approves this modification and authorizes expenditures in accordance with the**
7 **attached budget modification authorizing this change.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
10 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
11 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
