

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Agriculture Extension Program FY 2000 Budget Modification #3)**

RESOLUTION NO. 2000-313

1 **WHEREAS, the Agriculture Extension Program has identified savings of \$13,964.54 from its fiscal**
2 **year 2000 budget; and**

3 **WHEREAS, identified savings will be used to purchase capital equipment and professional**
4 **services the Agriculture Extension Program needs to sufficiently serve members of**
5 **the Tohono O'odham Nation; and**

6 **WHEREAS, the Agriculture Extension Program has identified savings of \$13,964.54 from its fiscal**
7 **year 2000 budget, attributed from the vacancy of personnel and fringe benefits; and**

8 **WHEREAS, the program's current base P.L. 638 budget does not have the necessary line items to**
9 **allow for the expenditure of funds to purchase the needed capital equipment and**
10 **professional services; and**

11 **WHEREAS, the Agriculture Extension Program has submitted for review and approval Budget**
12 **Modification No. 3 with two (2) new line items added to the budget.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the added two (2) line items for the Agricultural Extension Program budget: 750 -**
15 **Capital Equipment; 810 - Professional Services.**

16 **BE IT FURTHER RESOLVED that the line items be part of the Agriculture Extension Program's P.L.**
17 **638 base budget.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby approves the**
19 **Agriculture Extension Program's fiscal year 2000 P.L. 638 Budget Modification No. 3**
20 **and authorizes expenditures in accordance with the attached budget.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,086.45 FOR; -0-**
24 **AGAINST; 79.05 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
