

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 2001 Water Resources Study Program Budget Justification)**

**RESOLUTION NO. 2000-314**

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Water Resources Study**  
2 **Program under a P.L. 93-638 Contract with the Bureau of Reclamation; and**

3 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**  
4 **Nation; and**

5 **WHEREAS, the Tohono O'odham Nation has submitted a proposed contract Application complete**  
6 **with a budget totaling \$1,640,337.16 to the Bureau of Reclamation for the**  
7 **continuation of the Water Resources Study Program during the fiscal year 2001;**  
8 **and**

9 **WHEREAS, the United States has a statutory obligation pursuant to Section 303 (b)(1) of the**  
10 **Southern Arizona Water Rights Settlement Act to provide funds for the Water**  
11 **Resources Study Program; and**

12 **WHEREAS, the Water Resources Study Program does submit for review and approval of budget**  
13 **justification reflecting the amount of \$1,640,337.16.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does authorize**  
15 **expenditures per attached budget for the implementation of the Water Resources**  
16 **Study Program.**

17 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit: the Chairman, Vice Chairman and any designated Official**  
19 **are hereby authorized to negotiate and execute the Contract, provided however, that**  
20 **any amendments affecting the funding or funding levels of the Contract shall be**  
21 **submitted for further prior approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
24 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,085.5 FOR; -0- AGAINST;**  
25 **80.0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**  
26 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
