

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Distribution of Gaming Revenues by Population)**

RESOLUTION NO. 2000-318

1 WHEREAS, during the July 13, 2000 General Session, the Budget & Finance Committee did  
2 present for consideration by the Legislative Council three options for the distribution  
3 of gaming revenues, as follows:

- 4 1) equal distribution
- 5 2) per capita/population distribution
- 6 3) 50/50 split ( 1/2 equal and 1/2 per capita/population); and

7 WHEREAS, Option 1 was recommended by the Budget & Finance Committee; and

8 WHEREAS, on July 12, 2000 the Legislative Council Budget & Finance Committee made a  
9 presentation to the District Chairpersons regarding the distribution of gaming  
10 revenues to the Nation's districts; and

11 WHEREAS, the Legislative Council does hereby approve distribution of gaming revenues by  
12 population.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
14 approves and authorizes the distribution of gaming revenues by population to the  
15 districts by August 01, 2000.


16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
17 of JULY, 2000 at a meeting at which a quorum was present with a vote of 1,091.4 FOR;1,074.1  
18 AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section  
19 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
22 Stat. 984).

5 **submittal.**


