

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Distribution of Mining Royalties by Population)**

RESOLUTION NO. 2000-319

1 **WHEREAS, during the July 13, 2000 General Session, the Budget & Finance Committee did**
2 **present for consideration by the Legislative Council for the distribution of mining**
3 **royalties, as follows:**

- 4 **1) equal distribution**
5 **2) per capita/population distribution; and**

6 **WHEREAS, the amounts of mining royalties available for distribution to the Nation's districts as**
7 **of July 03, 2000, including interest accrued from August 31, 1997 through May 30, 2000**
8 **per attached amounts were presented to the District Chairpersons at a meeting held**
9 **on July 12, 2000; and**

10 **WHEREAS, the Legislative Council does hereby approve distribution of mining royalties by**
11 **population distribution.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **approves and authorizes the distribution of mining royalties by population to the**
14 **Districts.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
16 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 1,091.4 FOR; 1,074.1**
17 **AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
18 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**
