

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2001 Projected Revenues in the Amount of \$50,471,861.31)**

**RESOLUTION NO. 2000-320**

1 **WHEREAS, the Budget and Finance Committee reviewed the actual revenues for FY 2000; and**  
2 **WHEREAS, revenue sources for FY 2001 have been adjusted to reflect changes from actual**  
3 **revenues for FY 2000; and**  
4 **WHEREAS, the Budget and Finance Committee recommends adoption of FY 2001 projected**  
5 **revenues in the amount of \$50,471,861.31 to fund the Nation's budget for 2001.**  
6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
7 **approves the attached projected revenues, in the amount of \$50,471,861.31 for the**  
8 **purpose of funding the FY 2001 budgets of the Tohono O'odham Nation.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
10 **of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; 128.1**  
11 **AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
12 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
15 **Stat. 984).**
