7	WHEREAS,	during the July 14, 2000 Legislative Session, the Chairman of the Nation presented to						
8		the Legislative Council his justifications in vetoing Resolution 2000-300 (a copy of						
9		which is attached hereto); and						
10	WHEREAS,	the Legislative Council has reviewed the Chairman's objections and after						
11		consideration, again voted to pass Resolution No. 2000-300.						
12	NOW, THER	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby						
13		override the Chairman's veto by a vote of two-thirds of the votes cast.						
14 15 16 17 18 19	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 14TH. day of <u>[ULY, 2000]</u> at a meeting at which a quorum was present, and by a vote of <u>979.3</u> FOR; <u>1,186.2</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[03]</u> ABSENT, failed to pass because it did not receive a majority of two-thirds (2/3) <u>[1,443.6]</u> of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
