

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Distribution of Gaming Revenues by 50/50 Split (1/2 equal
and 1/2 population)**

RESOLUTION NO. 2000-341

1 **WHEREAS, during the July 13, 2000 General Session, the Budget & Finance Committee did present**
2 **three options on the distribution of gaming revenues for consideration by the**
3 **Legislative Council: 1) equal distribution; 2) population distribution; and 3) 50/50 (1/2**
4 **equal and 1/2 population); and**

5 **WHEREAS, by Resolution No. 2000-318 the Council approved the distribution of gaming revenues**
6 **by population and the resolution was subsequently vetoed by the Chairman of the**
7 **Nation; and**

8 **WHEREAS, on August 07, 2000 the Legislative Council failed to override the veto; and**

9 **WHEREAS, the Chairman of the Nation in his veto justification stated his support for the 50%/50%**
10 **split concept (1/2 equal and 1/2 population) distribution of gaming revenues.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **the distribution of gaming revenues by the 50%/50% split (1/2 equal and 1/2 population).**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
14 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,233.85 FOR; 931.65**
15 **AGAINST; -0- NOT VOTING; and 101 ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


