8	WHEREAS, on August 07, 2000 the Legislative Council failed to override the veto; and
9	WHEREAS, the Chairman of the Nation in his veto justification stated his support for the 50%/50%
10	split concept ($lac{1}{2}$ equal and $lac{1}{2}$ population) distribution of gaming revenues.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
12	the distribution of gaming revenues by the 50%/50% split (½ equal and ½ population).
