from the membership roll.**


**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.

Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
