

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2000 Department of Human Services Division of Alcohol/Substance Abuse Program
Rehabilitation Aftercare Program Budget Modification Number Three)**

RESOLUTION NO. 2000-347

1 **WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating the**
2 **Division of Alcoholism and Substance Abuse Program Component under P.L. 93-638**
3 **Master Health Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance**
5 **Abuse - Rehabilitation Aftercare Program of available carryover dollars in the amount**
6 **of \$176,788.62 allocated to cover the remaining three months salaries and special**
7 **medical services.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 9 **1. It hereby approves and authorizes expenditures in accordance with the attached**
10 **budget modification #3 submitted by the Department of Human Services.**
11 **2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman**
12 **and any designated official are hereby authorized to negotiate and execute the**
13 **contract.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
15 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,879.15 FOR; 222.3**
16 **AGAINST; 64.05 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**
