

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Vi-ikam Doag Industries, Inc. Fiscal Year 2000 Budget Amendment)**

RESOLUTION NO. 2000-348

1 **WHEREAS, the Legislative Council approved the FY 2000 budget for Vi-ikam Doag Industries, Inc.**
2 **("VDI") for the sum of \$1,457,060.00 to be funded from Public Law 99-503 funds; and**

3 **WHEREAS, since the time of the budget approval, VDI has received an economic development**
4 **opportunity, known as the Kimblewick Project, that will require Two Million Dollars**
5 **(\$2,000,000.00); and**

6 **WHEREAS, the business venture is consistent with stated objectives in the VDI Charter; and**

7 **WHEREAS, Public Law 99-503 funds are available for economic development; and**

8 **WHEREAS, the Board of Directors of VDI passed a resolution on June 29, 2000 recommending that**
9 **the San Lucy District make available the sum of \$2,000,000.00 from Public Law 99-503**
10 **funds as start up funds for the business venture; and**

11 **WHEREAS, the San Lucy District considered the recommendation of VDI and passed Resolution**
12 **No. SL 07-104-00 approving the business venture and requesting the immediate**
13 **release of \$2,000,000.00 from the Public Law 99-503 funds to VDI so as to allow VDI to**
14 **proceed with the business venture; and**

15 **WHEREAS, the annual budget of VDI has been modified to reflect a new line item for the business**
16 **venture and the sum of \$2,000,000.00 for a total FY 2000 budget of \$3,457,060.00.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council does hereby**
18 **approve the FY 2000 budget modification for VDI.**

19 **BE IT FURTHER RESOLVED THAT the Tohono O'odham Legislative Council does hereby approve**
20 **the immediate transfer of \$2,000,000.00 from Public Law 99-503 funds to VDI.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
22 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,917.45 FOR; -0-**
23 **AGAINST; 248.05 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) & (3), (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
25 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


