

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 98-188 to include the Development of a Revised
Plan, Design and Implementation of the San Xavier Cooperative Association
Farm Rehabilitation and the Development of the Farm Extension)**

RESOLUTION NO. 2000-349

1 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 98-188 granting**
2 **authority to the San Xavier District Council to prepare a Cooperative Agreement with**
3 **the Bureau of Reclamation for the design review of the Farm Rehabilitation Plan for**
4 **the San Xavier Cooperative Association (SXCA) Farm; and**

5 **WHEREAS, it is necessary to commence the design review of the SXCA Farm Rehabilitation Plan;**
6 **and**

7 **WHEREAS, the design review process will include the development of a revised plan, design and**
8 **implementation of the Farm Rehabilitation for the SXCA Farm, and the development**
9 **of a farm plan, design and implementation strategy for the Farm Extension; and**

10 **WHEREAS, the San Xavier District Council through Resolution SXDC 07-00-03 is requesting that**
11 **Resolution No. 98-188 scope of work be amended to include the 1) development of a**
12 **revised plan and design for the Farm Rehabilitation for the San Xavier Cooperative**
13 **Association Farm; 2) the implementation of the Farm Rehabilitation; 3) the**
14 **development of a farm plan, design and implementation strategy for the Farm**
15 **Extension; and 4) the construction of the Farm Extension; and**

16 **WHEREAS, the San Xavier District and the San Xavier Cooperative Association have presented to**
17 **the following Tohono O'odham Legislative Council Committees: Agriculture, Water**
18 **Resources and Natural Resources, and upon their review have recommended the**
19 **amendment of Resolution No. 98-188 as requested by the San Xavier District Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **amend the scope of work in Resolution 98-188 to include 1) the development of a**
22 **revised plan and design for the Farm Rehabilitation for the San Xavier Cooperative**
23 **Association Farm; 2) the implementation of the Farm Rehabilitation; 3) the**
24 **development of a farm plan, design and implementation strategy for the Farm**
25 **Extension; and 4) the construction of the Farm Extension.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
27 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 2,085.5 FOR; -0-**
28 **AGAINST; 80.0 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**


