

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2001 Budget for the Tohono O'odham Judicial Branch and Appropriating**  
**Funds in the amount of \$5,271,380.00)**

**RESOLUTION NO. 2000-355**

1 **WHEREAS, the 2000 fiscal year ends at midnight, September 30, 2000 and all spending authority**  
2 **granted under the 2000 budgets ends at that time; and**

3 **WHEREAS, the continued operation of the Judicial Branch of the Tohono O'odham Nation**  
4 **requires adoption of an operating budget, the grant of spending authority and the**  
5 **appropriation of funds for FY 2001; and**

6 **WHEREAS, the Judicial Branch hereby requests \$234,873.00 to supplement the programs budget**  
7 **to meet the costs of increased salaries for Market Adjustment and Longevity per the**  
8 **FY 2001 Budget Instructions. This will increase the Tohono O'odham Judicial Budget**  
9 **to a grand total of \$5,271,380.00; and**

10 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget that reflects**  
11 **the need of the Branch, said budget is attached hereto and incorporated by reference;**  
12 **and**

13 **WHEREAS, the Judicial and the Budget & Finance Committees of the Legislative Council of the**  
14 **Tohono O'odham Nation have reviewed this budget and recommends its approval**  
15 **and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the**  
17 **Tohono O'odham Nation that it approves the FY 2001 budget submitted by the Judicial**  
18 **Branch.**

19 **BE IT FURTHER RESOLVED that funds in the amount of \$5,271,380.00 including Market**  
20 **and Longevity Adjustments, are appropriated and authorized to be expended from**  
21 **sources of funding approved by this Council for support of the FY 2001 budget of the**  
22 **Tohono O'odham Judicial Branch.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>th</sup> Day**  
24 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
26 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**
