

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Veteran Affairs Office Budget Modification #1)**

RESOLUTION NO. 2000-361

1 WHEREAS, the Tohono O'odham Nation Veteran Affairs Office has a budget of \$210,459.36 for  
2 fiscal year 2000 budget; and  
3 WHEREAS, it is necessary to do a modification to purchase a modular building to establish an  
4 office for the Veteran Affairs Office to sufficiently serve Veterans and their  
5 dependents of the Tohono O'odham Nation; and  
6 WHEREAS, the Tohono O'odham Nation Veteran Affairs program has submitted for review and  
7 approval of Budget Modification #1.  
8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
9 approves the modified amounts to purchase a modular building.  
10 BE IT FINALLY RESOLVED that the Legislative Council hereby approves the Veteran Affairs  
11 Office Fiscal Year 2000 Budget Modification No. 1 and authorizes expenditures in  
12 accordance with the attached budget.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day  
14 of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,993.7 FOR; -0-  
15 AGAINST; -0-NOT VOTING; and 171.8 [05] ABSENT, pursuant to the powers vested in the Council by  
16 Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
17 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat. 984).




