

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Employment & Training Program State of Arizona - PY 2000  
Youth Budget Program, Modification #1)**

RESOLUTION NO. 2000-365

1 WHEREAS, the Tohono O'odham Nation Employment & Training Program has been funded  
2 through the State of Arizona - PY 2000 Youth Program in the original amount of  
3 \$176,598.00; and

4 WHEREAS, carry over amounts in the amount of \$38.00 have been identified through final  
5 allocations from the State of Arizona Department of Economic Security; and

6 WHEREAS, the Tohono O'odham Nation, in conjunction with the State of Arizona will cost share  
7 any and all reasonable, allowable, and allocable charges; and

8 WHEREAS, the Employment & Training plan works for the Nation with referrals, case  
9 management, pre-employment training, job creation, support services.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
11 approve the State of Arizona, PY 2000 Youth Program, Budget Modification #1 in the  
12 amount of \$176,636.00.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono  
14 O'odham Nation's Officials, to wit; the Chairman and any designated official are  
15 hereby authorized to negotiate and execute the contract, provided however, that any  
16 amendment affecting the funding or funding levels of this contract shall be submitted  
17 for further prior approval by this Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day  
19 of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,929.65 FOR; -0-  
20 AGAINST; 235.85 NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by  
21 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
22 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
24 Stat. 984).


