

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Employment & Training Program Department of Labor -
Comprehensive Service Program PY 1999)**

RESOLUTION NO. 2000-367

1 **WHEREAS, the Tohono O'odham Nation recognizes the end to federal legislation of the Job**
2 **Training Partnership Act and the creation and implementation of the Workforce**
3 **Investment Act; and**

4 **WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has been renamed as the Tohono**
5 **O'odham Nation Employment & Training Program which will include all programs**
6 **formerly under JTPA/NEW/WtW ; and**

7 **WHEREAS, the savings for the JTPA PY 99 is identified as \$180,773.00 and JTPA funds will be**
8 **carried forward to the WIA Comprehensive Service Program and reassigned as WIA**
9 **funds; and**

10 **WHEREAS, Program Year 1999 funds will not be reimbursed until the savings are carried forward**
11 **to the new WIA grant; and received grant and award notice; and**

12 **WHEREAS, this budget is included in the Comprehensive Service Program, will commence upon**
13 **approval of this resolution and will expire June 30, 2002.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
15 **does hereby approve the Department of Labor - Comprehensive Service Program PY**
16 **1999 Budget authorized for expenditure from the date of approval of this resolution**
17 **until June 30, 2002 in the amount of \$180,773.00.**

18 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
19 **O'odham Nation's Officials, to wit; the Chairman and any designated official are**
20 **hereby authorized to negotiate and execute the contract, provided however, that any**
21 **amendment affecting the funding or funding levels of this contract shall be submitted**
22 **for further prior approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
24 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 105 ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
