

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Acceptance and Use of the LSTA Grant for a Conference on Tribal Libraries, Research Libraries and Museums in the O'odham Community from LSTA funds distributed by the Arizona Department of Library, Public Records, and Archives)

RESOLUTION NO. 2000-377

1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia
2 Library and Archives, the library agency of the Tohono O'odham Education
3 Department.

4 NOW THERE BE IT RESOLVED that the Tohono O'odham Legislative Council supports the
5 Venito Garcia Library and Archives' LSTA grant application for a conference on Tribal
6 Libraries, Research Libraries, and Museums in the O'odham Community.

7 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the use of
8 the grant monies and hereby waives indirect costs, which is a condition on the funds
9 of the grant agency.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10th. Day
12 of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,942.9 FOR; -0-
13 AGAINST; -0- NOT VOTING; and 222.6 [4] ABSENT, pursuant to the powers vested in the Council by
14 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
15 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
17 Stat. 984).




