

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nursing Home Project Budget Modification to provide funding for the Tohono O'odham
Nursing Care Authority and for Initial Operations of the Archie Hendricks, Sr. Center)**

RESOLUTION NO. 2000-383

1 **WHEREAS, the Tohono O'odham Nation, by Resolution No. 98-512 chartered the Tohono**
2 **O'odham Nursing Care Authority (TONCA) and further resolved that the "... Nursing**
3 **Home Project of the Tohono O'odham Department of Human Services shall continue**
4 **to manage the day-to-day operations of the nursing home project and scholarship**
5 **program until implementation of a transition plan to transfer assets of the Nation to**
6 **the Tohono O'odham Nursing Care Authority"; and**

7 **WHEREAS, the Tohono O'odham Nursing Care Authority (Authority) and the Nursing Home**
8 **Project recognize the need for the Authority to begin the process of hiring key staff**
9 **and purchase major equipment, furniture and fixtures for installation at the nursing**
10 **care facility; and**


11 **WHEREAS, the Authority does not now have any funds independent of the Nation, the Authority**
12 **and the Project agree that the existing budget of the Nursing Home Project be**
13 **modified to provide funds to be utilized by the Authority to cover the initial operation**
14 **expenses; and**

15 **WHEREAS, the Authority has presented a budget modification to the Chairman of the Nation, the**
16 **Health and Human Service Committee and the Budget and Finance Committee for**
17 **review and recommendation for approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
19 **hereby approves the budget modification request for one million dollars (\$1,000,000)**
20 **to be utilized by the Authority from August 2000 through January 2001 for expenses**
21 **and costs incurred and obligated for initial operations expenses.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,942.9 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 222.6 [06] ABSENT, pursuant to the powers vested in the Council**
25 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
26 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
