

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Attorney Contract with California Indian
Legal Services)**

RESOLUTION NO. 2000-384

1 **WHEREAS, by Resolution No. 99-590, the Tohono O'odham Legislative Council approved an**
2 **Attorney Contract with California Indian Legal Services to provide legal**
3 **representation to the Nation in connection with certain cases pending in California**
4 **under the Indian Child Welfare Act; and**

5 **WHEREAS, the Attorney Contract is in the amount of \$19,000 for fiscal year 2000; and**

6 **WHEREAS, the additional sum of \$30,000 is required for legal fees and expenses to assure**
7 **uninterrupted legal representation for fiscal year 2000; and**

8 **WHEREAS, sufficient funds are available in the budget of the Office of Attorney General to**
9 **supplement the Attorney contract by such amount; and**

10 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of**
11 **Amendment No. 1 to the Attorney Contract to increase the Contract amount by**
12 **\$30,000.**

13 **NOW, THEREFORE, BE IT RESOLVED that:**

- 14 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to**
15 **the Attorney Contract with California Indian Legal Services in the form attached**
16 **hereto, which increases the Contract amount by \$30,000 payable from the fiscal**
17 **year 2000 operating budget of the Office of Attorney General.**
- 18 **2. The Chairman of the Nation is authorized and directed to execute Amendment No.**
19 **1 to such Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
21 **of AUGUST, 2000 at a meeting at which a quorum was present with a vote of 1,942.9 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 222.6 [08] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**




