15		$regardless\ of justification\ or\ terminology\ be\ put\ before\ the\ districts\ and\ membership$
16		of the Tohono O'odham Nation for comment and approval prior to action by the
17		Tohono Oʻodham Legislative Council.

19		hereby acknowledged and supports the San Pedro Community and the Schuk Toak
20		District on the compensation issue for the Legislative Council.

22		all Legislative Council compensation increases to the districts and membership of
