1 **WHEREAS, the Commerce Committee has submitted a budget for consideration by the Tohono**
2 **O'odham Legislative Council for purposes of attending meetings with the State,**
3 **National Indian Gaming Association (NIGA), and other Indian gaming related**
4 **conferences and/or meetings; and**
5 **WHEREAS, the Commerce Committee Twelve-Month Budget submitted in the amount of**
6 **\$70,500.00 is effective October 01, 2000 to September 30, 2001; and**
7 **WHEREAS, the budget will be made part of the Operating Expense of Desert Diamond Casino.**
8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
9 **approves the Commerce Committee Twelve-Month Budget in the amount of**
10 **\$70,500.00.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
12 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,371.3 FOR; 794.2**
13 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
14 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
15 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat. 984).**


