
1 WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No. 2000-412,  
2 *"Providing Authority to Tohono O'odham Community College to Enter into Self-*  
3 *Determination Contracts with the Bureau of Indian Affairs"; and*

4 WHEREAS, the Budget & Finance Committee recommends deletion of reference to Budget &  
5 Finance Committee in the last WHEREAS clause.

6 NOW, THEREFORE, BE IT RESOLVED that Resolution No. 2000-412 is hereby amended to  
7 delete reference to Budget & Finance Committee in the last WHEREAS clause.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day  
9 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,922.55 FOR;  
10 82.95 AGAINST; -0- NOT VOTING; and 160.0 [07] ABSENT, pursuant to the powers vested in the  
11 Council by Section 1 (l) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
12 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
14 18, 1934 (48 Stat. 984).
