


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorization to Continue San Xavier District Government Operations Pending**  
**Approval of its FY 00/01 Budget)**

RESOLUTION NO. 2000-418

1 WHEREAS, the San Xavier District is unable to forward its FY 00/01 approved budget to the  
2 Tohono O'odham Legislative Council (TOLC) before the end of the fiscal year; and  
3 WHEREAS, it is in the best interest of the San Xavier District (District) to continue its fiscal year  
4 operation pending the review and approval of its FY 00/01 budget by the TOLC; and  
5 WHEREAS, the San Xavier District has sufficient funds in its treasury to cover all expenditures  
6 during this interim period.  
7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
8 authorize the San Xavier District to continue to expend funds for its regular  
9 operation in the amount of three million eight hundred ninety thousand seventy nine  
10 and thirty six cents (\$3,890,079.36) at the FY 99/00 level until its FY 00/01 budget has  
11 been reviewed and sanctioned by the Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day  
13 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,877.4 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and 288.1 [10] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).






