

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Choulic Community FY-00 Budget Amendment and Modification)**

RESOLUTION NO. 2000-427

1 **WHEREAS, the Choulic Community Representatives presented a budget amendment and**
2 **modification in the amount of Seventeen thousand two hundred seventeen dollars**
3 **and no cents (\$17,217.00) to be taken from line items 610.32 Salaries, 661.32 Mileage,**
4 **727.32 Materials Capitol Equipment, 759.32 Other Equipment, 770.32 Repair**
5 **Maintenance Equipment, 771.32 Repair Maintenance Vehicle Donations, 854.32**
6 **Clothing Assistance for the creation of one (1) new line item, namely:**
7 **861.32 MISCELLANEOUS in the amount of Seventeen thousand two hundred seventeen**
8 **dollars and no cents (\$17,217.00).**

9 **Justification - Non emergency assistance; to provide services for two (2) community**
10 **members for electricity and water line hook up; and**

11 **WHEREAS, any changes in the justifications, additions and/or transfer of funds between budget**
12 **line items are to be reviewed and approved by the District Council.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **Choulic Community FY-00 Budget new line item 861.32 Miscellaneous.**

15 **BE IT FURTHER RESOLVED that the budget modification in the amount of Seventeen thousand two**
16 **hundred seventeen dollars and no cents (\$17,217.00) be distributed to new line item**
17 **in aforementioned.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH. Day**
19 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,585.6 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 579.9 [12] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
