

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 2000-379, "Authorizing the Demolition and Hazardous
Waste Clean-Up of the Old Tribal Building and Authorizing the
Chairman of the Nation to Contract for Such Services")

RESOLUTION NO. 2000-433

1 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 2000-379,**
2 **"Authorizing the Demolition and Hazardous Waste Clean-Up of the Old Tribal**
3 **Building and Authorizing the Chairman of the Nation to Contract for Such Services";**
4 **and**

5 **WHEREAS, an amendment was made to include language as item #4 in the final resolve clause**
6 **to read that "The land vacated by the building will be turned over to the Tohono**
7 **O'odham Veterans Affairs Office"; and**

8 **WHEREAS, this amendment was omitted due to a clerical error.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
10 **No. 2000-379 is hereby amended to include as Item No. 4 in the resolving clause:**

11 **4. The land vacated by the building will be turned over to the Tohono O'odham**
12 **Veterans Affairs Office.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH. Day**
14 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,585.6 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and 579.9 [10] ABSENT, pursuant to the powers vested in the Council**
16 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


