RESOLUTION NO. 2000-440

1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia
2 Library and Archives, the library agency of the Tohono O'odham Education
3 Department; and

4 WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No. 2000-376
5 approving the acceptance and use of the LSTA Planning Grant for an O'odham
6 Children's Literature Project from LSTA funds distributed by the Arizona Department
7 of Library, Public Records and Archives; and

8 WHEREAS, the Executive Branch requires authority to expend funds for the LSTA Planning Grant.

9 NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is authorized to expend funds for
10 the Venito Garcia Library and Archives pursuant to the planning grant.


11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day
12 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
13 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
14 Section 1 ((f)) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
15 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat. 984).




