(Authorization to continue Sells District Operations Pending approval of FY 2001 Budget)

RESOLUTION NO. 2000-441

1 **WHEREAS, Sells District is unable to complete its FY-2001 approved budget for review by Tohono**
2 **O'odham Legislative Council before the end of FY-2000; and**

3 **WHEREAS, it is in the best interest of Sells District to continue its fiscal year operations pending**
4 **review and approval of its FY-2001 budget by the Tohono O'odham Legislative**
5 **Council; and**

6 **WHEREAS, Sells District has sufficient funds to cover its expenditures during the interim period.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **authorizes Sells District to continue to expend funds to cover operational cost at its**
9 **FY-2000 Budget level until its FY-2001 Budget has been reviewed and approved by the**
10 **Tohono O'odham Legislative Council.**


11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
12 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
14 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
15 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat. 984).**


