

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Bureau of Indian Affairs Budgets)**

RESOLUTION NO. 2000-443

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs; and**

3 **WHEREAS, the Legislative Council has approved Resolution No. 2000-284 granting the Executive**
4 **authorization to submit the Annual Funding Agreement and contract amendment to**
5 **the Indian Self Determination Act Master contract, and conduct negotiations; and**

6 **WHEREAS, the Executive Branch requires authority to expend for the following programs subject**
7 **to Congressional appropriation or Continuing Resolution:**

- 8 **A. Economic Development (Credit & Finance) - \$226,910.00 + \$39,482.34 (Est. IDC)**
- 9 **B. Individuals with Disabilities Education Act (IDEA) - \$56,635.91 + \$5,732.56 (Est.**
10 **IDC)**
- 11 **C. Higher Education Scholarships - \$706,437.00 + \$10,765.72 (Est. IDC)**
- 12 **D. Johnson O'Malley - \$149,658.00 + \$23,279.00 (Est. IDC)**
- 13 **E. General Law Enforcement Services - \$3,074,021.99 + \$534,879.83 (Est. IDC)**
- 14 **F. Judicial Services - \$275,058.00 + \$47,860.00 (Est. IDC)**
- 15 **G. Employment Assistance - \$319,423.00 + \$10,665.00 (Est. IDC)**
- 16 **H. Water Resources - \$113,778.00**
- 17 **I. Agriculture Extension - \$83,338.00 + \$14,500.81 (Est. IDC)**
- 18 **J. Social Services/Family Assistance - \$2,305,858.00 + \$135,505.00 (Est. IDC)**
- 19 **K. Children's Home - \$728,790.40 + \$126,809.53 (Est. IDC)**
- 20 **L. Adult Group - \$338,506.60 + \$58,900.15 (Est. IDC)**
- 21 **M. Family Preservation - \$105,061.00 + \$18,280.61 (Est. IDC)**
- 22 **N. Wildland Fire Management - \$208,000.00 + \$36,192.00 (Est. IDC)**

23 **NOW, THEREFORE, BE IT RESOLVED THAT the Executive Branch is authorized to expend funds for**
24 **the programs listed herein above in the amounts indicated.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH. Day**
26 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
