

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Nursing Home Project Set-Aside Budget of \$8,613,779.41 for FY 2001)**

RESOLUTION NO. 2000-445

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation did authorize (in Resolution**
2 **Nos. 95-015, 95-016, and 95-113) the establishment of a Nursing Home Project Set-**
3 **Aside Account; and**

4 **WHEREAS, this account was established to provide the monies for training O'odham for the**
5 **operation of a Nursing Home Facility, plan, design, construct and to initially staff and**
6 **operate the facility; and**

7 **WHEREAS, the Nursing Home Project Office continues to provide project management with the**
8 **construction firm to continue construction of the skilled nursing facility, childcare**
9 **center and staff housing units.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the FY 2001**
11 **Budget in the amount of \$8,613,779.41 is hereby approved to construct the facilities,**
12 **provide for daily project operations and continued financial support for students to**
13 **staff the facility when construction is completed.**

14 **BE IT FINALLY RESOLVED that funds will be appropriated from the Nursing Home Project Set-Aside**
15 **Account.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
17 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
