

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of Budget Modification #1 for Department of Human Services/Division of**  
**Child Welfare Services-FY 2000 Title IV-B Child Welfare Service Subpart 1 and**  
**Promoting Safe and Stable Families, Subpart 2, Social Security Act)**

RESOLUTION NO. 2000-448

1 WHEREAS, the Tohono O'odham Nation is presently operating the FY2000 Grant with Title IV-B,  
2 Subpart 1 of the Social Security Act - five (5) year Plan; and

3 WHEREAS, any modifications affecting the funding and funding levels of the grant shall be  
4 submitted for review and approval by the Tohono O'odham Legislative Council; and

5 WHEREAS, the Title IV-B, Subpart 1 has been allocated funds in the amount of \$45,698.00 for  
6 budget period October 01, 1999 to September 30, 2001; and

7 WHEREAS, Title IV-B, Subpart 2 has been allocated funds in the amount of \$40,077.00 for budget  
8 period October 01, 1999 to September 30, 2001; and

9 WHEREAS, the Tohono O'odham Legislative Council does approve budget modifications for Title  
10 IV-B, Subpart 1 and Title IV-B, Subpart 2.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 12 1. It does approve the Title IV-B modification funding in the amount of \$45,698.00  
13 for Subpart 1 and \$40,077.00 for Subpart 2.
- 14 2. That the budget period is extended from September 30, 2000 to September 30,  
15 2001 to reflect the grant award period.
- 16 3. That the Tohono O'odham Nation official, to wit: the Chairman is hereby  
17 authorized to negotiate and execute the grant.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day  
19 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
21 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).
