

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing FY 2001 Initiative Administration Budget for O'odham
Charitable Organization for a Six Month Period @ \$169,985.69)

RESOLUTION NO. 2000-450

1 WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative cost
2 of implementing the provisions of the initiative; and

3 WHEREAS, by Resolution No. 2000-447 the Legislative Council did approve fiscal year 2001
4 Initiative administration budgets prepared by the Executive Branch to continue
5 Initiative administration with a recommendation to exclude the O'odham Charitable
6 Organization budget; and

7 WHEREAS, the \$1 million provided by the Initiative for grants has been depleted with a
8 remainder of \$339,971.39 for FY 2001; and

9 WHEREAS, the Tohono O'odham Charitable Board is currently soliciting the Nation's Districts
10 for replenishment of the \$1 million from gaming savings; and

11 WHEREAS, the Tohono O'odham Legislative Council recommends authorization of a six month
12 budget contingent upon replenishment of the \$1 million.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
14 approve a six month budget for the O'odham Charitable Organization in the amount
15 of \$169,985.69 contingent upon replenishment of the \$1 million currently being
16 solicited from the Nation's districts by the O'odham Charitable Organization.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day
18 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,895.15 FOR;
19 111.3 AGAINST; 159.05 NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council
20 by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
21 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
23 18, 1934 (48 Stat. 984).
