

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Continuing Resolution for Fresno Canyon Community, Baboquivari District)

RESOLUTION NO. 2000-452

1 **WHEREAS, the Baboquivari District Council met on September 25, 2000 and approved the**
2 **request from Fresno Canyon Community to utilize remaining funds from their FY**
3 **2000 Community Budget; and**

4 **WHEREAS, there is sufficient funds left in the amount of \$11,694.05 to complete the Fresno**
5 **Canyon water line project; and**

6 **WHEREAS, there are families who will benefit from the community project when the water lines**
7 **are completed; and**

8 **WHEREAS, the Fresno Canyon Community has enough funds in its FY 2000 Budget to carry over**
9 **and to cover all water line expenditures during this period; and**

10 **WHEREAS, any changes in the additions and/or transfer of funds and/or justifications are to be**
11 **reviewed by and approved by the Baboquivari District Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the continuation of the Fresno Canyon FY 2000 Budget (Baboquivari**
14 **District).**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**
16 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section**
18 **1 (d) (2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**




