RESOLUTION NO. 2000-457

1 WHEREAS, the Executive Branch has prepared and presented its fiscal year 2001 budget to the
2 Tohono O'odham Legislative Council; and

3 WHEREAS, the Executive Branch FY 2001 budgets funds regular department and program
4 operations and has been prepared to reflect the market and longevity for all
5 Executive Branch employees as authorized by the Council.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Executive
7 Branch fiscal year 2001 budget is hereby approved and it does hereby appropriate
8 \$38,420,936.18 for Operations and \$384,209.36 in Contingency Reserve.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day
10 of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,248.75 FOR;
11 \$37.7 AGAINST; 79.05 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council
12 by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
13 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat. 984).


