

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2001 Initiative Reserve Allocation)**

RESOLUTION NO. 2000-458

1 **WHEREAS, Initiative IN-01-97 authorized the establishment of reserves to fund the activities**
2 **required under the provisions of the Initiative; and**

3 **WHEREAS, the Legislative Council previously authorized the annual funding levels for the**
4 **Economic Development Grant program and it is necessary to approve and re-**
5 **authorize the amounts for FY 2001; and**

6 **WHEREAS, the Executive Branch has developed a budget to allocate funds for the design and**
7 **construction of Youth Centers within various districts; and**

8 **WHEREAS, the Executive Branch is estimating that the unexpended balance of the O'odham**
9 **Charitable Grant reserve will be approximately \$299,767.00, and the Branch is**
10 **requesting re-authorization of this amount for FY 2001.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby re-**
12 **authorizes from the Economic Development Grant Reserve the amount of**
13 **\$3,500,000.00 for FY 2001.**

14 **BE IT FURTHER RESOLVED that \$15,500,000.00 is hereby re-authorized from the Youth Center**
15 **Project Reserve for FY 2001.**

16 **BE IT FURTHER RESOLVED that the unexpended balance of the O'odham Charitable Grant reserve,**
17 **in the amount of \$299,767.00 is hereby re-authorized for FY 2001.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
19 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**






