

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Gu Achi District FY 2001 Budget)**

**RESOLUTION NO. 2000-460**

1 **WHEREAS, the Gu Achi District Council at a Special Meeting on September 26, 2000, did discuss**  
2 **and approve the FY 2001 proposed budget in the amount of \$1,018,694.54 for district**  
3 **operations; and**

4 **WHEREAS, the FY 2001 proposed budget of Gu Achi District will be funded by the Gaming**  
5 **Revenues and Mining Royalties of the Tohono O'odham Nation and FY 2000 budget**  
6 **surplus monies; and**

7 **WHEREAS, the Gu Achi District have deposited all the revenues allocated to Gu Achi District in**  
8 **its bank account with First Union Securities; and**

9 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the Gu Achi District proposed**  
10 **FY 2001 budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the Gu Achi District FY 2001 budget to be expended in accordance with the attached**  
13 **budgets.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**  
15 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,554.3 FOR; 152.6**  
16 **AGAINST; 458.6 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
18 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**


