

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Indian Health Service 638 Savings Carry Over; Authorization of Expenditures)**

**RESOLUTION NO. 2000-462**

1 **WHEREAS, it was determined that the Indian Health Service 638 contracts had savings totaling**  
2 **\$391,343.45 (see breakdown below) from fiscal years 1996 through 1999; and**

3	<b>Management of Health</b>	<b>\$ 142,805.45</b>
4	<b>Psychological Services (\$344,562.00 - \$96,024.00 =)</b>	<b>\$ <u>248,538.00</u></b>
5	<b>Total</b>	<b>\$391,343.45</b>

6 **WHEREAS, of these savings \$17,038.00 of the Management of Health savings will be used to**  
7 **temporarily off-set the Human Services Executive Office's Fiscal Year 2001 Tribal Base**  
8 **Appropriation and \$125,767.45 will be used to temporarily off-set a portion of the**  
9 **Psychological Services Fiscal Year 2001 Tribal Base Appropriation; and \$248,538.00**  
10 **of the Psychological Services savings will be used to temporarily off-set the**  
11 **Psychological Services' Fiscal Year 2001 Tribal Base Appropriation.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes:**

- 13 **1. The carryover of the prior fiscal years 1996 through 1999 unencumbered**  
14 **obligations, totaling \$391,343.45.**
- 15 **2. That the balances as identified by the attached budgets are hereby carried over.**
- 16 **3. That any amount used to temporarily off-set the Fiscal Year 2001 Tribal Base**  
17 **budgets will be returned to bring Fiscal Year 2002 Tribal Allocations back to true**  
18 **base.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**  
20 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
