

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Bureau of Indian Affairs Social Service 638 Savings Carry Over; Authorization  
of Expenditures)**

RESOLUTION NO. 2000-463

1 **WHEREAS, it was determined that the Bureau of Indian Affairs Social Service 638 contract had**  
2 **savings of \$80,418.00 in Administrative Funds and savings of \$2,048,128.16 in Welfare**  
3 **Assistance totaling \$2,128,546.16 from fiscal years 1997 through 1999; and**

4 **WHEREAS, of these savings \$69,892.76 will be used to temporarily off-set the Human Services**  
5 **Executive Office's Fiscal Year 2001 Tribal Base Appropriation and \$126,403.02 will be**  
6 **used to temporarily off-set the Social Services' Fiscal Year 2001 Tribal Base**  
7 **Appropriation; and**

8 **WHEREAS, the remaining \$2,072,035.90 of these savings will be used to fund non-reoccurring**  
9 **expenses to meet the needs of the clients of the programs based on an assessment by**  
10 **the Department of Human Services.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes:**

- 12 **1. The carry over of the prior fiscal years 1997 through 1999 unencumbered**  
13 **obligations, totaling \$2,128,546.16.**
- 14 **2. That the balances as identified by the attached budget are hereby carried over.**
- 15 **3. That any amount used to temporarily off-set the Fiscal Year 2001 Tribal**  
16 **Base will be returned to bring Fiscal Year 2002 Tribal Allocation back to true**  
17 **base.**


18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**  
19 **of SEPTEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**




