

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for the Legislative Branch to Operate under a Continuing Resolution
for First Quarter Fiscal Year 2001 (Oct-Dec 2000))**

RESOLUTION NO. 2000-476

1 **WHEREAS, due to the delay/time constraints of the budget approval process of the Fiscal Year**
2 **2001 Legislative Branch Budget; and**

3 **WHEREAS, to date the Fiscal Year 2001 Legislative Branch Budget has not met all review and**
4 **approval per the budget process; and**

5 **WHEREAS, the Legislative Branch requests to operate under a Continuing Resolution in order**
6 **to obtain review from the remaining Districts per the Tohono O'Odham Legislative**
7 **Council Resolution No. 2000-042: "In Support of Schuk Toak District Council**
8 **Resolution, to Address Overtime, Bonus Payments and Salary Increases of the Tohono**
9 **O'Odham Legislative Council."**

10 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves a Continuing Resolution**
11 **for the Legislative Branch for a period of 90-days.**

12 **BE IT FURTHER RESOLVED that appropriated and authorized funds in the amount of 535,968.50**
13 **not exceed 25% of FY 2000 Budget be expended from Fiscal Year 2001 Projected**
14 **Revenues.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council will resume its October**
16 **2000 General Session on Tuesday, October 10, 2000.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
18 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,028.95 FOR; -0-**
19 **AGAINST; 378.95 NOT VOTING; and 757.6 [12] ABSENT, pursuant to the powers vested in the Council**
20 **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**


