8		to the Legislative Council his justifications in vetoing Resolution No. 2000-437 (a

10	WHEREAS,	the Legislative Council has reviewed the Chairman's objections and after							
11		consideration, again voted to pass Resolution No. 2000-437.							
12	NOW, THER	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby							
13		override the Chairman's veto by a vote of two-thirds of the votes cast.							
14 15 16 17 18	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the <u>19TH.</u> day of <u>OCTOBER</u> , <u>2000</u> at a meeting at which a quorum was present, and by a vote of <u>834.95</u> FOR; <u>1,330.55</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[0]</u> ABSENT, failed to pass because it did not receive a majority of two-thirds (2/3) [1,443.66] of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
