

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override of Vetoed Resolution No. 2000-437, "Rescinding the Confirmation of the
Appointment of Richard Clifton as Director of Public Safety for the Tohono
O'odham Nation")**

FAILED

RESOLUTION NO. 2000-478

1 **WHEREAS, during the September 26, 2000 Special Session of the Tohono O'odham Legislative**
2 **Council, the Council did pass Resolution No. 2000-437; and**

3 **WHEREAS, upon presentation of Resolution No. 2000-437 to the Chairman of the Tohono**
4 **O'odham Nation, he did disapprove thereof and returned it to the Council with his**
5 **objections in accordance with the provisions of Article VII, Section 5 of the**
6 **Constitution of the Tohono O'odham Nation; and**

7 **WHEREAS, during the October 19, 2000 Legislative Session, the Chairman of the Nation presented**
8 **to the Legislative Council his justifications in vetoing Resolution No. 2000-437 (a**
9 **copy of which is attached hereto); and**

10 **WHEREAS, the Legislative Council has reviewed the Chairman's objections and after**
11 **consideration, again voted to pass Resolution No. 2000-437.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **override the Chairman's veto by a vote of two-thirds of the votes cast.**

14 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 19TH.**
15 **day of OCTOBER, 2000 at a meeting at which a quorum was present, and by a vote of 834.95 FOR;**
16 **1,330.55 AGAINST; -0- NOT VOTING; and [0] ABSENT, failed to pass because it did not receive a**
17 **majority of two-thirds (2/3) [1,443.66] of the votes cast as required by Section 5 of Article VII of the**
18 **Constitution of the Tohono O'Odham Nation.**
