12	AGAINST; <u>-0-</u> NOT VOTING; and <u>[-0-]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 <u>(d)(2) & (3)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
13	the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15	18, 1934 (48 Stat. 984).
