

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 2000-476, "Approving Continuing Resolution for the
Legislative Branch at the FY 2000 Spending Level for the First Quarter;
Resume October 2000 General Session")**

RESOLUTION NO. 2000-479

1 **WHEREAS, on October 9, 2000, the Legislative Council enacted Resolution No. 2000-476, to**
2 **"Approving Continuing Resolution for the Legislative Branch at the FY 2000 Spending**
3 **Level for the First Quarter; Resume October 2000 General Session"; and**

4 **WHEREAS, the Legislative Branch Administration decided that Legislative staff should be**
5 **compensated at the FY 2001 level.**

6 **NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'Odham Legislative**
7 **Council hereby rescinds Tohono O'Odham Legislative Council Resolution No. 2000-**
8 **476.**


9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
10 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,118.7 FOR; 1,046.8**
11 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
12 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
13 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
14 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
15 **18, 1934 (48 Stat. 984).**




