

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adoption into the Tohono O'odham Nation)

RESOLUTION NO. 2000-485

1 WHEREAS, ELVIA LOPEZ-GARCIA has made application for adoption in the Tohono O'odham
2 Nation pursuant to Section 2 of Article II of the Constitution of the Tohono O'odham
3 Nation; and

4 WHEREAS, the Enrollment Committee has reviewed the respective application, and has made a
5 final determination that ELVIA LOPEZ-GARCIA is ½ degree or more of Papago-
6 Tohono O'odham Indian blood, and has made a recommendation to the Tohono
7 O'odham Council that the application be approved, all in accordance with the
8 provisions of the Enrollment Ordinance; and

9 WHEREAS, the Tohono O'odham Legislative Council has reviewed the recommendations of the
10 Enrollment Committee and the evidence submitted in support of the individual
11 application.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the
13 application for adoption filed by:

ELVIA LOPEZ-GARCIA 4098-ND-99

15 is hereby approved and hereby adopted into membership of the Tohono O'odham
16 Nation.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
18 of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
19 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
20 Section 2 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'odham
21 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
22 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
23 of the Act of June 18, 1934 (48 Stat. 984).
