

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Sells District FY 2001 Budget)**

RESOLUTION NO. 2000-489

1 **WHEREAS, the Sells District Treasurer presented the Sells District FY 2001 Budget to the Tohono**
2 **O'odham Legislative Council for review and approval; and**

3 **WHEREAS, the FY 2001 Budget covers the cost for the District's Administration in the amount of**
4 **\$543,433.33; and**

5 **WHEREAS, Tohono O'odham Legislative Council did review and approved the Sells District**
6 **Administration Budget.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
8 **Sells District FY 2001 Budget in the amount of \$543,433.33.**

9 **BE IT FURTHER RESOLVED that the remainder of the Gaming Distribution will be deposited in an**
10 **Interest Bearing Account to cover unforeseen District cost subject to the approval of**
11 **the Tohono O'odham Legislative Council.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH, Day**
13 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
16 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


