

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a Lobbying Contract between the Tohono O'odham Nation and**  
**Ducheneaux, Taylor & Associates)**

RESOLUTION NO. 2000-492

1 WHEREAS, the Tohono O'Odham Nation recognizes the need to obtain legislative and  
2 administrative advocacy services in regard to programs and services of the Federal  
3 government of the United States of America; and

4 WHEREAS, the firm of Ducheneaux, Taylor & Associates has continued to provide adequate  
5 services in Fiscal Year 2000 including; to advise the Nation regarding Federal  
6 initiatives; to act as liaison with the Federal Executive and Legislative Branches; to  
7 arrange meetings with Federal Officials; to provide specific reports on services  
8 provided directly to the Nation; and

9 WHEREAS, funds in the amount of \$60,000.00 plus \$10,000.00 have been appropriated in  
10 anticipated expenses by the Legislative Council of the Tohono O'odham Nation for the  
11 purpose of obtaining these services in Fiscal Year 2001.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the  
13 Tohono O'odham Nation's Officials to wit; the Chairman or any designated official  
14 area hereby authorized to negotiate and execute the contract provided in the amount  
15 of \$60,000.00 plus \$10,000.00 in anticipated expenses, and that any amendments  
16 affecting the funding levels of the contract shall be submitted for further prior  
17 approval by this Council.

18 BE IT FURTHER RESOLVED that the contract period will be from October 01, 2000 through  
19 September 30, 2001.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day  
21 of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,712.8 FOR; 452.7  
22 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
23 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
26 Stat. 984).
