9	WHEREAS,	the Attorney General and Human Resources Office recommends extension of the					
10		Attorney Contract for fiscal year 2001 to enable Mr. Yoder to continue his advice and					
11		representation of the Nation in these matters, including submission of the 401(k)					
12		Plan to the Internal Revenue Service for approval.
