

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with Robert R. Yoder)

RESOLUTION NO. 2000-493

1 **WHEREAS, pursuant to Resolution No. 2000 - 453, the Tohono O'odham Legislative Council**
2 **approved a 401(k) Plan for the Nation's employees, together with various documents**
3 **related thereto, and authorized submission of the Plan to the Internal Revenue**
4 **Service for approval; and**

5 **WHEREAS, pursuant to Resolution No. 2000-047, the Nation entered into an Attorney Contract**
6 **with Robert R. Yoder for a term which ended on September 30, 2000; and**

7 **WHEREAS, Mr. Yoder is a specialist in the field of retirement plans, and provided the Nation with**
8 **advice and drafted documents related to the 401(k) Plan; and**

9 **WHEREAS, the Attorney General and Human Resources Office recommends extension of the**
10 **Attorney Contract for fiscal year 2001 to enable Mr. Yoder to continue his advice and**
11 **representation of the Nation in these matters, including submission of the 401(k)**
12 **Plan to the Internal Revenue Service for approval.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 14 **1. The Tohono O'odham Legislative Council approves an Attorney Contract with**
15 **Robert R. Yoder in the amount of \$10,000 for fiscal year 2001 and in the form**
16 **attached hereto.**
- 17 **2. The Legislative Council appropriates the sum of \$10,000 from Account No. 1-1006-**
18 **605 to fund the Attorney Contract.**
- 19 **3. The Chairman of the Nation is authorized to execute the Attorney Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH,**
21 **Day of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 128.1 [05] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
