

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract with Dee Ann Keller)**

RESOLUTION NO. 2000-497

1 **WHEREAS, by Resolutions No. 99-597 and 2000-385, the Tohono O'odham Legislative Council**  
2 **approved an Attorney Contract, and Amendment No. 1 thereto, with Dee Ann Keller**  
3 **to provide legal representation to the Nation with respect to Juvenile Case No. 99 JV**  
4 **290 (97 JV 1259) which is pending in Colorado under the Indian Child Welfare Act; and**

5 **WHEREAS, the Attorney Contract expired on September 30, 2000; and**

6 **WHEREAS, continued representation is necessary to assure uninterrupted legal representation**  
7 **for fiscal year 2001; and**

8 **WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for**  
9 **fiscal year 2001 in the amount of \$5,000; and**

10 **WHEREAS, sufficient funds are available in the operating budget of the Office of Attorney General**  
11 **for fiscal year 2001 for an Attorney Contract in such amount; and**

12 **WHEREAS, the Domestic Affairs Committee recommends approval of the Attorney Contract on**  
13 **such terms.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

15 **1. The Tohono O'odham Legislative Council hereby approves the Attorney Contract**  
16 **with Dee Ann Keller in the amount of \$5,000 for the fiscal year ending September**  
17 **30, 2001 and in the form attached hereto.**

18 **2. The Chairman of the Nation is authorized and directed to execute the Attorney**  
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**  
21 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 128.1 [03] ABSENT, pursuant to the powers vested in the Council**  
23 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


